



## ORGANISATION MEMBERSHIP

### How much does UK Theatre Organisation Membership cost?

The subscription fee varies according to membership banding, as detailed below.

The subscription year commences on 1 January. Members joining part-way through the year pay a pro-rata subscription for that year.

### Venues

Subscriptions (excluding Group Members) are **based on an organisation's turnover** on UK Theatre related activity. This is defined as the figure for revenue turnover in accounts for the company and all subsidiary companies where activities relate to the principal business of performance.

Subsidiary companies would include, but not be limited to, a theatre or venue's own catering operation or trading and shop outlet. The figure should include gross box office turnover, net of VAT, and the net revenue from all ancillary and trading activities, including catering and bars or income shown in the company's accounts received from franchised operations.

One free Professional Membership is included per band i.e. Band 1 includes one staff login, Band 2 includes 2, Band 3 includes free and so on. Organisations can purchase additional Professional membership allocations for their employees as 'Top-up' memberships if required.

### Production Companies / Commercial Producers

The subscription rate for Organisation Members who are Commercial Producers is in two parts:

- a **flat fee** payable at the start of the calendar year. This fee equivalent to Band 1 (see table below)
- a **variable fee** is payable by the end of each calendar year. The variable fee is calculated according to the number of weeks of drama and/or music theatre, opera or dance touring undertaken in the year by productions produced or managed by the member. UK Theatre will contact the member toward the end of the year asking them to confirm the number of weeks and type of touring, if any, undertaken. At this point the member will be invoiced for the variable fee which is then payable.

A single free Professional Membership is included. Additional Professional membership

Annual membership fee (can be paid quarterly by direct debit) for individuals who earn more than £26,500 a year	£166 inc VAT

<b>Professional Plus Member</b>	
Annual membership fee (can be paid quarterly by direct debit)	£222 ex VAT

<b>Partner Member</b>	
Annual membership fee (includes two staff memberships)	£334 ex VAT (Plus one-off joining fee of £224 ex VAT)
Additional 'Top up' staff memberships (each)	£40 ex VAT
